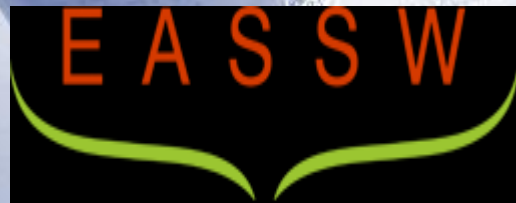

# Training Nature

- **Human training**, that allows establishing a relation with the subject/others,
- **Theoretical training**, which allows organizing a plan of intervention adjusted to the problem of the individual and facilitates an interdisciplinary discourse with other actors and the knowledge intervening in the problem
- **Technical training** in the use of adequate and effective methodologies to respond to the problem of the individual and develop their active citizenship through the training and empowerment of personal, social, interpersonal, relational and work skills.

# Values

- **Humanist values**, which center their attention on Man and respect for oneself;
- The **democratic values** that develop the necessary conditions for the development of its personality and its social and civic participation in the society;
- The **political and economic values**, which promote the principle of subsidiarity and equal opportunities and social rights;
- The **educational values**, sustained on the scientific dimension of the knowledge where the professional is supported and base their intervention plan.

# Study Plan

- **Social Work Fundamentals-** principles and concepts, ethics and deontology, methods and techniques of Social Work (individual, family and collective), theories (diagnosis) and strategies of social intervention and communication in Social Work;
- **Public policies and social protection system** - measures of social welfare, conceptualization and operationalization of social responses, institutional framework and administration of social services (public network, private network and social solidarity network);

# Study Plan

- **Intervention Models in Social Work and contemporary social problems** - human development and interaction between Man and Society or Citizen and Social Environment, Equality *Versus* Inequality, dependence and social vulnerability, social structure and social and cultural diversity;
- **Social Work Technical Tools** - Social assistance, Systematic social follow-up, home visit, interview, observation, social information, social report, socio-familial characterization, Supervision, social expertise, individual readjustment plan, promotion and protection agreement, individual educational plan, Case evaluation, Scales and Information and communication technologies.

# Study Plan

- **Supervised Practices and experiential training in Social Work** - courses of practical training (laboratories and Training) where each one experiences the Know-How, Know-do and Know-Be through the correlation established between Theory and Practice, Practice and Theory.

# TRAINING PROFILE

**The cycle of studies, within the framework of the competences for the exercise of the profession, seeks to form the following professional profile:**

**1<sup>st</sup> Cycle**

- Concession; analyze; diagnosis, synthesis and problem solving;
- Application of knowledge; adaptation to new situations and quality of intervention;
- Understanding of information;
- Training to work autonomously and in a team;
- Organization, planning and evaluation.
- **The cycle of studies of the Degree in Social Work promotes the following competencies:**
- Analysis and know how to situate Social Work intervention in the context of public social policies, inequality and national and international social problems, within the framework of modern social institutions;
- Apply and operationalize the theoretical and methodological knowledge in Social Work, based on its principles, values and purposes in the professional intervention and within the contemporary debate of this area of knowledge;



# CONT:

- Dominate and operationalize the approach focusing on the subject, the family, the community, the organizations, as well as empowerment, social advocacy, networking and partnership;
- Diagnosticate, program, execute and evaluate intervention in Social Work, through the use of theoretical, technical and methodological references fundamental to a qualified and qualified professional practice;
- To enable the student to solve social problems in the context of the diversity of social and family contexts;
- Management of the complexity of problem situations in order to formulate information and answers based on the principles of social and ethical responsibilities;
- Skills that enable them to continue lifelong learning with a high degree of autonomy.

## **The master's degree in Social Work promotes the following competencies: 2nd Cycle**

- Apply specific theories and methodologies of Social Work (in the construction of the theoretical object in the investigation process and intervention in Social Work);
- To elaborate technical instruments of support to the diagnosis, the intervention, the investigation and the evaluation of the social problems;
- To base and argue the ethical-political, theoretical-methodological and instrumental nature of Social Work;
- Analyze Social Work and its practices at the national and international level, at the level of its approaches, its privileged relationship with vulnerable or socially disadvantaged social groups and multidisciplinary work;
- Evaluate, in a critical and systematic way, the professional practice, its results, contexts and determinations.
- Skills that enable them to continue lifelong learning with a high degree of autonomy.

## **The Doctorate in Social Work cycle promotes the following competencies: 3rdCycle**

- Investigate social problems, professional practice and know how to distinguish / use the different methods and techniques of research;
- Systematize knowledge in Social Work promoting its theoretical construction;
- Develop research projects and carry out original work, contributing to the innovation of knowledge and practices in Social Work;
- Disseminate the scientific knowledge produced through publication and editing;
- Improve communication skills with peers, the scientific community and society in general;
- Create an identity of the scientific area of the Social Work and, in particular, about its object of study, clarifying the foundations, procedures and conclusions of its analysis based on the research.
